1. CALL TO ORDER AND ROLL CALL

Marty Hirschorn called the meeting to order at 10:08 am.

2. OPPORTUNITY FOR PUBLIC COMMENT

There was no public comment.

3. APPROVAL OF MINUTES

Mr. Hirschorn made a motion to approve the October 10, 2019 minutes. Chiaku Chukwuogor seconded the motion. Minutes approved.

4. DISCUSSION ITEMS

A. Update on Mansfield Opportunity Zone

Ms. Chukwuogor referenced the CT DECD conference about opportunity zones that she attended that included state officials and other staff from various Connecticut cities and towns. The meeting included how towns and cities have approached redevelopment sites and how they went about revitalizing certain areas. She suggested that the Mansfield staff team talk to other Connecticut towns about their tables at the conference in terms of photos and vertical displays.

Mr. Hirschorn spoke about the need to keep people in Connecticut and asked about information regarding the achievements of towns and cities in 2019.

Cynthia van Zelm updated Mr. Hirschorn and Ms. Chukwuogor about the progress CERC is making on their work with the Town on promoting Mansfield's opportunity zone. The last major piece to finish is a marketing plan for the promotion of the opportunity zone. A market analysis and list of potential incentives have been completed.

Mr. Hirschorn asked whether anyone had taken advantage of the tax incentives in Connecticut opportunity zones in 2019, when the maximum benefit is available. Mr. Hirschorn also asked for a breakdown of how the benefit decreases each year. Ms. van

Zelm said she would follow-up with CERC and invite them to a future subcommittee or full EDC meeting.

B. Review of Town and State of Connecticut Opportunity Zone websites

Ms. van Zelm then showed the Town of Mansfield website that breaks down the

opportunity zones by main areas of focus. In addition, she showed the State of
