Approval of Minutes

New Business

- a. **Oaks on the Square New Resident Move In (K. DeLany)** – K. DeLany read the traffic plan for The Oaks on the Square New Resident Move In Days as presented in the agenda packet. Motion made by L. Painter, seconded by F. Mitchell, to approve the traffic plan for move in day on August 21, 2021 and August 22, 2021 as presented. Motion passed unanimously.
- b. **Request for Stop Light at the RT 195 and Chaffeeville Road Intersection (F. Titus)** – F. Titus attended the meeting to explain her request for a stoplight due to increased traffic at this intersection during certain times of the day as well as when events are happening in town. A request shall be sent to the CTDOT asking for a traffic study and sightline study to be completed at this intersection. This request was approved by consensus.
- c. **Concerts at Betsy Paterson Square (K. Paterson)** – K. Paterson handed out a map showing the request for road barricades at two locations for concerts on Thursday nights in August during the hours of 4:00pm to 9:00pm. This request was approved by consensus.
- d. **Request for Traffic Study at 305 Storrs Road (D. Dilaj)** – D. Dilaj presented the location and issue for which a resident requested the Town's assistance. At 305 Storrs Road (Rt. 195), the resident would like a traffic study to be conducted for sightline issues and determine if the speed is appropriate for this area of Storrs Road (Rt. 195). A request shall be sent to CTDOT asking for a traffic study and

speed study to be completed in this area of Storrs Road (Rt. 195). This request was approved by consensus.

- e. **Upstage Communications Event at Betsy Paterson Square on September 22, 2021 (E. Gibson & D. Kegler)** – K. Paterson presented the request for a road closure on Dog Lane as shown on the map to park an airstream and truck for this event. The correct time is 9:00am to 5:00pm to allow for setup and breakdown after the event. Motion made by R. Aylesworth, seconded by B. LaVoie, to move the barricade to the intersection of Dog Lane and RT 195 as well as a barricade at the intersection of Dog Lane and Royce Circle between the hours of 9:00am to 5:00pm. Motion passed unanimously.

Other Business

- a. **Greek Independence Program on September 24th and 26th (I. Tomazos)** – R. Aylesworth spoke about the event scheduled and those invited to attend. K. Paterson will speak with C. VanZelm about the event and try to find out more details. Leave as Old Business.
