Snowshoe Rental Form and Agreement

Snowshoes and poles are available to rent at a cost of \$10 each/day or partial day of rental. Snowshoes can be kept overnight for an additional \$10. Total fee for renting snowshoes overnight is \$30, 2 day rental plus overnight rental. Rental includes one pair of snowshoes and poles. Hiking boots are recommended. Children and adult sizes are available.

A \$30 refundable security deposit is due at the time of the reservation. The deposit must be made either by check or credit card. Furthermore, I understand that I am personally responsible for the repair or replacement of lost, damaged, or stolen items that I have leased and/or used from the Town of Mansfield. Determination of the reparability of any damaged items is at the sole discretion of The Mansfield Parks and Recreation Department. If the damage/loss exceeds the amount of the security deposit, additional charges must be paid within five (5) working days once notified of charges. Failure to do so may result in suspended usage of facilities and steps may be taken to collect fees. The Town of Mansfield is not responsible for any damage to personal property during the rental period.

Waiver of Participant by Parent or Self: I hereby agree to release, discharge, and hold harmless the Town of Mansfield, its directors, officers, employees, agents, contractors, and/or volunteers from any and all liability or obligation that may occur during either my use or the use by my minor child of the Town's snowshoes and poles. This includes any injury or damage to the person or property of others, which I or my minor child causes or contributes to while using the snowshoes, poles, or any other equipment rented from the Town. I understand that participation in any recreational or sport activity involves risk, and I further understand that the Town of Mansfield does not provide insurance for participants.
