(1) "Shall the total amount of \$22,322,252 (\$3,511,472 for the Town of Ashford; \$11,157,419 for the Town of Mansfield, and \$4,379,900 for the Town of Willington) be appropriated for the operation and maintenance of the Regional School District Number 19 Public School System for the July 1, 2021 to June 30, 2022 fiscal year?"
