## Overview

### General Fund

#### Estimated Revenues FY24/25

1. Member Town Contribution - \$20,449,961

Based on adopted budget.

2. Ag-Ed Grant - \$951,136

Based on adopted budget and capped by State Statute. Increase assumed based on lost revenue from tuition billing as capped by the State.

3. Regular Education Tuition – \$2,004,118

Slightly under budget based on final enrollment.

4. Ag-Ed Tuition – \$379,872

Decrease based on 58% tuition cap imposed by State legislation.

5. Special Education Tuition - \$574,899

Increased tuition numbers based on increased enrollment in special education.

6. Interest Income and Misc. - \$173,216

Based on YTD income.

### Expenditures

There are overages in special education tuition and transportation based on an increase in special education enrollment. A spending freeze was implemented by the Superintendent.

## **Other Funds:**

### Miscellaneous Special Revenue Funds

The 1122 Fund includes a variety of special projects funded by specific revenue sources. The main projects are Special Education reserve, ASTE Grant and Adult Education.

### Debt Service Fund

Fund Balance at June 30, 2025 is \$377,169. This balance will be drawn down as principal and interest payments are made.

### Capital Projects

Included in this report are project length schedules of revenues and expenditures for all open projects at this time. Capital project transfers will be proposed later this evening for Finance approval. The security improvement line is overspent due to encumbrances. Purchases were encumbered in June to ensure timely completion of entryway remodel. Funding is available as of July 1 to cover these costs.

### Cafeteria Fund

The Cafeteria Fund has been included this quarter as it will be important for the Board to monitor this going forward. Expenditures exceeded revenues by \$210,481 for FY2025, resulting in a negative fund balance of \$157,865 at fiscal year-end.

### Internal Service Funds

#### Health Insurance Fund (Town of Mansfield, Mansfield BOE, and Region 19 BOE)

Revenues exceeded expenditures through the quarter by \$292,752. Fund balance increased from \$3,982,960 at July 1, 2024 to \$4,275,711 at June 30, 2025. Claims through May averaged \$759,616 (on a fiscal year basis) as compared to \$663,549, the average for last fiscal year which represents a 14.5% increase. June claims were not available but will be included in next quarter's report. To be considered fully funded, the Health Insurance Fund needs to maintain a fund balance of approximately \$2.1 million.

#### Workers' Compensation Fund

Fund Balance at June 30, 2025 is \$54,116 a \$28,785 decrease.
