## **About the Program**

The Fee Waiver Ordinance helps make essential Town services more accessible by reducing or waiving certain fees for qualifying residents. It's designed to ensure that everyone in our community can benefit from these services—regardless of income.



## **Who is Eligible?**

To be eligible for the fee waiver applicants must have lived in the town for more than six months and meet income guidelines based on HUD definitions for “extremely low”, “very low”, or “low” income.

Depending on income level, residents may receive a 25%, 50% or 75% reduction in applicable fees not reimbursed by a third party.

Covered Year is from July 1-June 30.

## **What Services are Covered?**

The Fee Waiver Ordinance helps reduce costs for a variety of Town services and programs, making them more accessible to residents who qualify.

Covered services include:

- Parks & Recreation Programs
- Community Center Memberships and Programs
- Parks & Recreation After School & Summer Camp Programs
- Recycling & Refuse Fees
- Ambulance Fees



Some services are not included under the ordinance, such as:

- Parks & Recreation bus trips, private lessons, materials fees, merchandise, and child care.
- Senior Center trips and special events.

## **How to Apply**

If you think you may be eligible for a fee waiver you can apply through the Mansfield Human Services office. Applications can be completed on-line, by mail, or in the office. You will be asked to provide documentation related to your current income, and proof of residency. This information will be held in strict confidence. Once you have been approved for a waiver it will apply to any of the covered services.

Eligibility must be renewed annually starting July 1.



## **What if my Income Changes?**

Any changes affecting your eligibility status over the course of the year must be reported to the Town so that we can evaluate whether or not you continue to qualify for the waiver.
