

LEGAL NOTICE
TOWN OF MANSFIELD

The electors of the Town of Mansfield are hereby warned to meet at their respective polling places in said town on Tuesday, November 5, 2019 for the following purposes:

- I. To cast their votes in a Town election to fill the offices of Town Council, Board of Education (full term), Board of Assessment Appeals (full term), Planning and Zoning Commission (full term), Planning and Zoning Commission (to fill vacancy for two years), Planning and Zoning Commission Alternate (to fill vacancy for two years), Zoning Board of Appeals (full term), Zoning Board of Appeals Alternate (to fill vacancy for two years), and Regional Board of Education (full term).
- II. To vote on the following local question for approval or disapproval of a resolution approved by the Town Council on June 10, 2019, which question will be placed on the voting machines under the following heading:

"SHALL THE TOWN OF MANSFIELD APPROPRIATE \$50,512,000 FOR COSTS WITH RESPECT TO THE DESIGN, CONSTRUCTION, EQUIPPING AND FURNISHING OF A PRE-K THROUGH GRADE 4 ELEMENTARY SCHOOL TO BE LOCATED ON TOWN-OWNED PROPERTY AT 134 WARRENVILLE ROAD IN MANSFIELD, AND THE DEMOLITION OF THE EXISTING SOUTHEAST ELEMENTARY SCHOOL, AND AUTHORIZE THE ISSUE OF BONDS AND NOTES TO FINANCE THE PORTION OF THE APPROPRIATION NOT DEFRAID FROM GRANTS?"

The vote on the above question will be taken under the authority of Sections 406 and 407 of the Town Charter and Sections 7-7, 9-369 and 9-369d of the Connecticut General Statutes. A vote of "YES" will be a vote for approval of the resolution, and a vote of "NO" will be a vote for disapproval of said resolution. The full text of the resolution is on file and open to public inspection in the office of the Town Clerk. Application for absentee ballots should be made to the Town Clerk's office. Electors shall vote on the question at their respective polling places. Persons qualified to vote in town meetings who are not electors will vote at the following polling place: Registrar of Voters Office, Audrey P. Beck Building, 4 South Eagleville Road in Storrs, Connecticut.

Notice is hereby given that the locations of the polling places are as follows:

District 1 – Mansfield Community Center, 10 South Eagleville Road
District 2 – Mansfield Fire Department Station 107 (Eagleville), 889 Stafford Road
District 3 – Buchanan Auditorium, Mansfield Library, 54 Warrenville Road
District 4 – Annie Vinton School, 306 Stafford Road

Paper ballots will be used. The polls will open at 6:00 a.m. in the morning and will remain open until 8:00 p.m. in the evening. Absentee ballots will be counted at the following central location: Audrey P. Beck Building, 4 South Eagleville Road in Mansfield, Connecticut. Election Day Registration will also take place in the Audrey P. Beck Building.
