



# Lenard Hall – CSA Update!

When the facility reopened in July, Lenard Hall implemented a health screening process for facility access in an effort to go above and beyond standards implemented by the State ([see the Sector Rules here](#)). As Connecticut progresses into its next reopening phase, we see schools returning to more days in person, and other less restrictive standards. After careful consideration and review with our local health officials, health screening measure will be discontinued as of October 15<sup>th</sup>.

## **Please Continue to Self-Screen Before You Come!**

We cannot tell you how much we appreciate the caution all of our members and staff, please continue screening at home:

- Have you been in close contact with confirmed case of COVID-19 in the past 14 days?
- Are you experiencing a new cough, new shortness of breath, or new sore throat?
- Have you had a fever of 100.4F or greater in the last 48 hours?
  - Take your temperature - if it is 100.4 or higher, please don't come in.
- Remember - an answer of "YES" to any of these means **you need to stay home**.

In an effort to ensure the safest environment for our CSA students and staff, and to meet mandates passed down by the CT Office of Early Childhood (OEC), there has been several changes to private lesson procedures. Please read a summary of the Lenard Hall changes as well as basic care information to be implemented below:

## **Capacity Limitations**

Please mind the social distancing signs and reminders to keep yourself and others as safe as possible, keeping in mind that each student should bring no more than 2 guest when coming in got a private lesson

## **Hours of Operation**

- Lenard Hall is open on Tuesdays 4-5:30PM & Wednesdays 2-5PM. ## **Physical/Social Distancing**

- Private lesson rooms 3, 4, & 6 will be closed.
- Staff and private lesson students will be required to maintain physical/social distancing during sessions.
- Wearing of a face mask will be required for all Lenard Hall staff, students, and guests

## **Intensified Cleaning & Disinfecting**

- Intensified and frequent cleaning, sanitizing, and disinfecting of frequently touched surfaces and shared spaces (restrooms) will occur multiple times per day and between each use for shared objects. Private lesson rooms will be sanitized between each use.
- Hand sanitizer and/or soap and water will be readily available to all visitors and staff.

## **Staff**

- In addition to our traditional orientation and training, all CSA instructors and Reception staff will be required to attend a training specific to COVID-19 health and safety regulations mandated by local, state and national health agencies before returning to work.
